

**2026 DOLPHINS CANCER CHALLENGE DAY 1 CLUB GIVEAWAY
FULL OFFICIAL RULES**

**PROMOTION OPEN ONLY TO LEGAL RESIDENTS OF FLORIDA 18 YEARS AND OLDER
AT TIME OF ENTRY**

BY COMPLETING AND SUBMITTING AN ENTRY FOR THE GIVEAWAY, EACH PARTICIPANT UNCONDITIONALLY ACCEPTS AND AGREES TO THESE FULL OFFICIAL RULES, WHICH FORM A CONTRACT BETWEEN EACH PARTICIPANT AND SPONSOR. WITHOUT LIMITATION, THIS CONTRACT INCLUDES RELEASES AND INDEMNITY OBLIGATIONS ON THE PART OF EACH PARTICIPANT AND A LIMITATION OF PARTICIPANT'S RIGHTS AND REMEDIES. - 1. Giveaway:** The Dolphins Cancer Challenge Day 1 Club Giveaway described herein, including the prize drawing, shall be hereinafter referred to as the "Giveaway." The Giveaway begins on August 10, 2026, at 8:00 a.m. Eastern Time ("ET") and ends on August 10, 2026, at 11:59 p.m. ET ("Giveaway Period").
- 2. No Purchase Necessary:** NO ENTRY FEE, PAYMENT, OR PROOF OF PURCHASE IS NECESSARY TO ENTER OR WIN. The Promotion is void outside of the State of Florida. Must be 18 years or older at time of entry to enter.

Any participant who registers for DCC XVII on August 10, 2026, during the Giveaway Period will automatically receive one (1) Entry; or

No purchase, payment, donation, or registration for DCC XVII is necessary to enter or win by this method, and entering via the AMOE will result in one (1) Entry.

After the participant has completed one (1) of the above methods, participant will automatically be entered into the Giveaway and receive one (1) entry. Entries submitted in compliance with the foregoing and all other terms of these Full Official Rules shall be hereinafter referred to as "Entries" or, individually, an "Entry." Limit one (1) Entry per participant during the Giveaway Period. Any participant that submits more than one (1) Entry may be disqualified and such additional entries will not be accepted. To be valid, the Entry must be received no later than 11:59 p.m. ET on August 10, 2026. Sponsor's computer shall be the official timekeeping mechanism for the Giveaway. All times mentioned in these Full Official Rules are Eastern Time, unless expressly noted otherwise. A non-conforming and/or otherwise incomplete Giveaway entry will not be accepted. Sponsor assumes no responsibility for incomplete, lost, stolen, late, misdirected, misplaced, mutilated, or garbled entries or communications, entries not received regardless of cause, or for technical failures of any kind, including, without limitation, malfunctioning of any network, server, telephone, carrier service or equipment, infection by virus or bugs, or other failure. 4. Prize/Drawing: *Grand Prize:* Four (4) Club Level tickets to the Miami Dolphins 2026 regular season Home Opener (valued at \$350 each) and Four (4) Pregame Sideline Passes (valued at \$275 each) in connection with the Home Opener. One (1) Grand Prize will be awarded to one (1) winner. The Home Opener is currently scheduled to be held at Hard Rock Stadium, located at 347 Don Shula Drive, Miami Gardens, Florida 33056 on September 27, 2026, at 1:00 p.m. ET.

Approximate retail value (ARV): \$2,500.00.

All additional expenses that are not specifically included in the prize as stated above, including, but not limited to, personal transportation, parking, insurance, and federal, state, and local taxes, title, and registration expenses are the winner's sole responsibility and may need to be prepaid, in part or in whole, prior to receipt of prize. The terms and conditions of the tickets awarded as part of the prize will govern in the event a legal game, as defined by NFL, is not played or held due to weather conditions, an act of God, an act of terrorism, civil disturbance, or any other reason.
